## YOUR GUIDE TO ONLINE REGISTRATION — SPLENDOUR RELEASE —

*at Bloomdale (Stage 25b) Online Registrations OPEN  
Wednesday 9 August 2017 at 12 noon*

### REGISTRATION REQUIREMENT

- If you are on the Setmore webpage (which you would have arrived at had you successfully clicked on the link contained in the email correspondence from Bloomdale AVID Property Group sent early August) before registrations open you will need to refresh the page via your browser at 12 noon on 9 August 2017 to reveal the 14 available appointment times.
- There is a strict limit of one registration per person or couple.
- To be eligible to purchase a lot in the Splendour Release, customers must be registered on the Bloomdale database prior to booking an appointment through Setmore. In addition to this, the full name of the client whose name appears on the booking must be registered on the Bloomdale database.
- To register, you need to provide us with your **full name**, email address, mobile phone number and home address.
- If you intend to use a Power of Attorney, you will need to provide a certified copy to the Bloomdale sales team by Friday 11 August 2017, otherwise you may not be able to proceed on the day of appointment.
- The **full name** and address you provide to register for a lot, must be the full name and address you intend to include on the contract to purchase the lot. Bloomdale reserves the right to cancel your appointment if this information is not submitted correctly, or if you are found to have submitted more than one registration.
- Registrants will be required to present photo ID via a driver's license or passport at your appointment.
- Successful registrants will receive an email confirmation immediately after completing the online registration process. Please be sure to check your email.
- Applicants who did not complete their booking information correctly will be sent a cancellation email by close of business on the day of registrations (9 August 2017), regardless of a confirmation email being issued.

## ON THE RELEASE DAY

- The land release will take place on Saturday 12 August 2017.
- Registrants will be required to be at the Bloomdale Sales & Information Centre (Sully Court, Diggers Rest) at the time of their confirmed appointment. Bloomdale reserves the right to cancel your appointment if the registrants show up more than 5 minutes after the confirmed appointment time.
- Registrants must provide photo identification via a driver's license or passport at the appointment
- At the confirmed appointment time, registrants will meet with the Bloomdale sales team and have the opportunity to select a preferred lot and secure that via an initial deposit of \$1,000 on the day of release. Within seven days customers will then sign the land sale contract (that is subject to a 3-day cooling off period), and pay the balance of a 10% deposit.

## DEPOSIT REQUIREMENTS

- An initial deposit of \$1,000 during your scheduled appointment via EFTPOS (credit, cheque or savings accounts) or cheque, no cash.
- Please ensure your EFTPOS limit is adequate and arrange this with your respective bank prior to your appointment to ensure payment may be processed.
- Please also note AMEX is not accepted to pay the deposit.

## LOTS NOT SOLD ON THE RELEASE DAY

- Any lots not sold on the day of release will be available to the public from 12 noon the following day (Sunday 13 August), and will be available for sale on a first come, first served basis.
